### ISSUE SUMMARY

## KEY QUESTIONS FOR ANALYSIS AND DISCUSSION

- a. How does critical and relational analyses of colonization and settler colonialism foster dialogues about the ways in which the settler colonial and carceral state seeks to promote differences between groups? How might these dialogues contribute to greater awareness and collaboration in resisting the logics of the state?

- b. How has the dominant understanding of the World War II incarceration of Japanese Americans in the United States obscured the longer history of the removal, dispossession and genocide of American Indians? How does the work of Horiuchi, Leong and Vicenti Carpio, and Phu provide different perspectives about the ways in which American Indians and Japanese Americans both experienced carceral logics, and how were Japanese Americans mobilized by the state to justify ongoing settler colonialism?
- c. The authors in this volume use different media and research to engage with the different carceral and colonial logics. How are these different approaches useful to better understand the complexity of the ways diverse histories and carceral logics intersect and result in shared experiences?
